FAST TRACK NEWS AND EVENTS – JAN. 13, 2014

Trade Promotion Authority (Fast Track) Bill - S1900 and HR 3830.

- The bill is nearly identical to the 2002 bill. Public Citizen currently doing a side-by-side analysis.
- A hearing will be held in the Senate Finance Committee this Thursday. 5 members of the committee so far have said they are unhappy with the process so far.
- **Timeline for Senate bill:** mark-up of the bill with a vote, potentially, the last week of January or the 1st week in February
- No hearing set for the House yet
- House Republicans have said they will not take bill to the floor unless the President can guarantee 50 Democratic votes
- 151 Dems so far oppose Fast Track; about 27 GOP; need 217/218 NO votes (2 vacancies now)
- House will be in home districts Jan. 21-24. May be our last opportunity to meet face-to-face before House bill comes up for a vote.
- In-person letter drops are highly encouraged; 1 visit=100 emails
- Jan. 28, President's State of the Union address Fast Track/TPP may be mentioned, but probably won't be in the top 3.

- New Fast Track bill gives broader "consultation" with Congress, but this was in the previous bill. There are no consequences for ignoring consultation with Congress. Negotiating objectives from Congress were completely ignored in NAFTA agreement. No repercussions; it's not enforceable!
